Mark then introduced our guest speaker; Lucie Perrier, Councillor – Township of Greater Madawaska, Ward 1.

2. Lucie Perrier - Council/Township Update - 10:08

Lucie has been in Calabogie for 5 years, originally from Carleton Place. She loves the region and wanted to get involved in the community to find out what is going on [ex: trailer park]

Lucie opened the floor up to questions

Q: Chuck Weatherdon asked about the trailer park – why are regulations not being enforced?

A: Lucie Perrier responded that it was discussed at Council and is being reviewed – Mark provided background information to Lucy via email.

Mark: 30 letters sent were sent by NLA Cottagers in 2017 outlining all the same issues

Lucie: township just hired someone to review bylaws and possible infractions.

Chuck: the waste is the biggest issue – sewage, bathing in the lake [phosphate free? Etc]

Mark: provided example of another lake owner who was approached by bylaw about a small structure, but the trailer park was ignored. The Association simply wants to know what the regulations are for the lot being used.

*Lucy was obviously unaware of the extent of the situation

Lucie: are they paying taxes for their property?

Group: no

Mark: Council has never addressed this or asked them to pay

Lucie: announced that Township Council will be meeting on July 15th for a Council meeting at 5:30pm in Council chambers, and if anyone would like to attend, they will be discussing this issue.

Betty: *referenced last years meeting minutes* Darryl Wagner was working on this. Fauve provided Lucie with a copy of 2018 meeting minutes.

Lots of discussion on the trailer park, including how they are burying hydro lines.

Chuck: Cottagers on the lake have been dealing with this for 30 years, and its never been addressed. The original 2 trailers have apparently been "grandfathered in", however they were told at the beginning that they were not allowed to park more than two trailers on the lot. Two months ago one of the old trailers was removed and a new big one was brought in. There are at least 9-12 trailers now.

Lucie: this is a snowballing issue

Mark: the longer this goes on, the more of an issue it is for the Township. These trailer owners are not paying for the dump, OPP services, etc.

5. 10:28 - Neighbourhood Watch

10:29 – Jake Charron – Smithson Lane/East Side Way – No big news, Trailer park concerns, new decks – nothing fancy

Jake – Lake levels have been steady, its high but normal for now. We are well positioned for a drought if the rain doesn't come. We all hope the lake stays the level it is at currently.

10:32 – Brian McKay gave the Neighbourhood Watch report for Southside Way for Glenda who did not attend the meeting – nothing to report other than he has a big, white, noisy dog that barks at anything that moves

6. 10:35 - Anastasia Turner – Lake Steward Report

Anastasia reported on the 2018 data from testing 2 locations; the middle and the far north end of the lake near the trailer park. Overall, the water quality is good. There are 3 items reviewed during the testing:

Water Clarity, measured by Secchi Depth– the middle of the lake is 3.4 metres *down from a reported 6.2 metres in 2016, but the drastic change is because of a correction to the depth measurement process.

Calcium levels – These form the basis of the food chain and we want the levels to be high. New report: 2018 results: 31.8 mg per litre. Up from 30mg/L in 2017.

Phosphorus Levels: Phosphorus is a nutrient source for algae.

- Middle of Lake: 6.4 micrograms per litre which is very good it is down from 7.0 in 2017 [under 10 means we are an oligotrophic lake].
- North End of Lake: Slightly less phosphorus, no large difference between middle and north of lake.
- The middle of the lake is always tested. The north end was tested to determine if there is an impact from the Trailer Park

Best Practice to keep phosphorus levels down; regularly pump your septic tank, do not use fertilizers near lake, use phosphate free shampoos and soaps.

Last year there were some concern that the dump could be causing issues to the lake. The Township measures this for us, and there are no issues present during this round of testing.

Mark Gallivan: Please ensure that you wash your boats before putting them in the lake from outside water sources (7 day minimum) – we don't want zebra mussels!

10. Other news:

10:48 – Betty Gauthier: use of private roads for large construction vehicles, material deliveries (propane, lumber, etc) has a negative impact on the roads. The volunteers who maintain the roads do a great job but can't repair all the damage the big vehicles make. Property owners should be mindful of what is being done and help the volunteers when possible.

Peter Harcourt – Has seen road issues go up and down. Where the private road meets the public the area near Eastside Way is the worst. At Sullivan's – the potholes are terrible. Since everyone uses that part of the road, what can we do?

Mark G: each side of the lake has a private road committee for each road. Talk to Dean McDonald and Bev Harrison for Peter's concerns specifically about Southside Way.

Chuck: praise for people who maintain the north side road.

Karen Corkery: huge, white plastic barrel (human size) washed up on their property.

Gaetan St. Laurent: can we extend the cell tower reception? Anything we can do?

Fauve: The cell towers may have to be modified, the elevation and the tree line blocks access in most cases. You can get extenders for Wi-Fi and data use from your router, but not for phone calls.

MG: we are fortunate to have high speed internet

David Johnson: 5g cellular is coming to the area, which is much better. Cell phone costs are higher because we have limited users in our large surface area in Madawaska Township.
